**SUMMARY**

Discussed the following items relative to the licensee's request stated above:

1. Dr. Slack was reminded that a legible copy of the ABR certificate was still needed, and had not yet been received at this office. **Dr. Slack stated again that he would photograph the certificate and resubmit a legible copy.**
2. The licensee did not submit a complete copy of the University of Minnesota's Materials License documenting the licensed authorization of the preceptor AU for Dr. Farber; instead, the licensee had only submitted Page 1 of that license. The licensee was requested to submit a copy of the complete license for University of Minnesota. **Dr. Slack stated that he would obtain a copy of the whole license and submit it.**
3. Dr. Slack was reminded of our previous conversation regarding Dr. Farber, in that with respect to the request for 35.300 for Dr. Farber, we could, based on the information provided, only authorize him for oral administration of I-131 in quantities less than or equal to 33 mCi. **Dr. Slack confirmed his understanding of this point.**

Dr. Slack stated that he would respond with the additional information and clarification as soon as possible.
