Dear Mr. Stelly:

Thank you for your letter dated January 25, 2014 [Nuclear Regulatory Commission's (NRC) Agency wide Documents Access and Management System (ADAMS) Accession Number ML14044A093]. This submission was made as part of the corrective actions required by the NRC Confirmatory Order (EA-11-043) dated October 11, 2012 [ADAMS Accession Number ML113530799]. We have reviewed the information submitted and we find that it meets the requirements of Section V.E of the Order.

Section V.E - Beginning January 1, 2013, Accurate NDE shall submit to the NRC a copy of each procedure used when performing radiography activities within NRC jurisdiction, and each procedure used to train personnel who perform radiography activities within NRC jurisdiction. Starting in 2013, the procedures shall be submitted to the NRC annually by January the 31st of each year for 5 years.
