Dear Mr. Amarrah:

Enclosed is Amendment No. 2 to your NRC Material License No. 21-32818-01 in accordance with your January 7, 2014, request, signed by the Radiation Safety Officer (RSO) listed on the most recent amendment to your license, Henry A. Shevitz, M.D. Changes made to your license are printed in **bold font**.

On February 27, 2014, we sent you a letter requesting a written response on or before March 12, 2014. On March 19, 2014, March 26, 2014, and April 3, 2014, we called you to indicate that, to continue authorized radioactive materials use as listed on the license, we needed to receive your response in writing. To date, no written response has been received in our office.

Please note that we have amended your license to reflect the radioactive materials use status described in your request. As indicated, **no radioactive material may be used under the license without an amendment**. The expiration date has also been revised, in accordance with decommissioning requirements specified in Title 10 of the *Code of Federal Regulations* Section 30.36(d). We have also removed License Condition No. 13, as listed on the previous amendment to your license.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
