SUMMARY
We have reviewed your amendment request letter dated January 20, 2014, received in our offices on January 28, 2014, and find that we will need additional information as follows:

1. Please explain whether Mr. Klobuka is still serving as RSO at your facility or state the date when he left.
2. Please provide a course outline for Mr. Dowell's RSO training course taken on December 10 - 12, 2013.
3. Please provide a "Delegation of Authority" for Mr. Dowell, similar to the one you provided for Mr. Klobuka in your previous submittal dated April 3, 2013. Among other things, this letter must state that Mr. Dowell accepts the position as RSO and that he understands the duties and responsibilities associated with the RSO position. This letter must be currently dated and signed by a senior management official and Mr. Dowell.
4. Your letter states that your two Thermo Measure Tech Model 5201 gauges are currently under general licensure. In order for us to consider them for addition to your specific license please advise us whether these gauges are currently in active use at your facilities or are they offline and in storage.
5. Please confirm that the requirements in 10 CFR 31.5(c)(8)(i) - (iii) will be met in order for these gauges to be transferred from the vendor's specific license and your general license to your specific license only. These requirements include, but are not limited to, labeling changes and filing appropriate reports. 10 CFR Part 31 is available on our website at <http://www.nrc.gov>. >> next page
