Waiver_Purpose: UCS seeks background and context for this Salem NOED. A few years ago, UCS questioned a NOED issued for Fermi Unit 2 for a broken emergency diesel generator that would be out of service longer than the limiting condition for operation. UCS was later informed by an Inside NRC reporter that NRC Region I declined to issue an NOED to Salem for a similar power distribution impairment, largely because of our Fermi protest. We seek the requested records to see how this contemporary case compares to the two earlier cases.

Waiver_ExtentToExtractAnalyze: I seek the requested records in order to understand the basis for NRC's granting the licensee's NOED request as well as to understand how the NRC monitored plant conditions while the NOED was in force. My interest is in determining whether the NRC followed its NOED procedures in both granting the NOED and then in ensuring the licensee complied with all conditions within the NOED.

Waiver_SpecificActivityQuals: From the OIG audit of the NRC's NOED program (OIG/94A-24 dated October 17, 1994), I have monitored NOEDs. As noted in the response to No. 1 above, I contested the March 29, 2001, NOED (EA-01-092) granted for Fermi Unit 2. I wrote a letter dated April 13, 2001, to the NRC Inspector General contending that NRC violated its NOED procedures in granting that NOED. I seek the requested records in the Salem Unit 2 NOED to understand whether the agency properly applied its NOED procedures or, as in the Fermi Unit 2 case, deviated from them. When working for the NRC in 2009/2010 as an instructor, I taught technical specifications to NRC employees.

Waiver_ImpactPublicUnderstanding: From discussions with citizens and many local and state officials, many see NRC's issuance of NOEDs, exemptions, waivers, etc. as evidence that the NRC is captured by the industry. When appropriate, UCS seeks to correct misperceptions. For example, in the annual report on the NRC we released in March 2014, we described why we felt the NRC not moving Perry into Action Matrix column 4 and not conducting two scheduled Component Design Bases Inspections was proper. UCS strives to provide accurate commentaries in appropriate context and seeks to do so in this Salem NOED case.

Waiver_NatureOfPublic: More than 100 million Americans live within 50 miles of operating nuclear plants. While not all will be interested in this topic, many will be.

Waiver_MeansOfDissemination: Since 2011, UCS has issued annual reports on the NRC and nuclear plant safety. UCS also posts commentaries to our website (www.ucsusa.org) and blog (allthingsnuclear.org). Depending on what our analysis of the requested records concludes, UCS will likely use one or more of these communications vehicles to convey our views.
