SUBJECT: REVIEW OF TITLE 10 OF THE *CODE OF FEDERAL REGULATIONS* SECTION 70.72 SUMMARY OF CHANGES FOR GLOBAL NUCLEAR FUELS – AMERICAS, LLC (TECHNICAL ASSIGNMENT CONTROL NUMBER L33316)

Dear Mr. Murray,

On January 30, 2014, you submitted the Revised Integrated Safety Analysis (ISA), in compliance with Title 10 of the *Code of Federal Regulations* (10 CFR) Section 70.72(d)(2) (Agencywide Documents Access and Management System [ADAMS] Accession Number ML14041A353). The correspondence provided a brief statement of changes to the records made without prior U.S. Nuclear Regulatory Commission (NRC) approval, in accordance with regulations.

On March 10, 2014, we sent you a Request for Additional Information (RAI) (ADAMS Accession Number ML14059A210), to ascertain the basis for revisions to a selected number of changes identified in your January 30, 2014, submittal. On March 27, 2014, you supplied a response to the RAI (ADAMS Accession Number ML14086A099), providing a summary of the basis for the revisions and approval process. The staff completed a review of the responses to the RAI and find it to be adequate and in compliance with the regulations. The technical basis for the revisions was well described and management approvals were clearly identified. Additional controls were added or credited in some cases, thus enhancing safety. This completes the review of the update to the ISA, and was not a licensing action. A Safety Evaluation Report is not included or necessary.

Upon issuance of this letter, Technical Assignment Control Number L33316 will be closed.
