Dear Mr. Citron-Vega:

This refers to your license amendment request dated February 10, 2014. Enclosed with this letter is the amended license. In accordance with your request, we amended your license to add three new facilities as authorized locations of use/storage, and remove three other facilities previously authorized as locations of use/storage from the license. The vacated facilities located at Bo. Guzman, Rio Grande; Carretera PR 8838, San Juan, and Marginal Ponce Bypass, Ponce may be released for unrestricted use. **Please note that NRC regulations require that you request and receive an amendment to your license prior to storing licensed material at any facility not listed on the license as storage/use location, or releasing for unrestricted use any facility identified on the license as authorized location of storage/use.**

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
