Discussion: (4/7/14; 10:00) I spoke with Mr. Waer concerning the progress of the company in putting together a list of those clients whose specifically-licensed XRF units who had yet to convert to generally-licensed devices. Mr. Waer stated that he should be able to e-mail me a list within the next ten days. Mr. Waer wanted to confirm that the list should only cover those devices distributed to companies under NRC jurisdiction. I confirmed that companies within non-Agreement States, federal facilities, companies on tribal lands, and those companies in the U.S. possessions should be on the list. (4/15/14; 13:35) I left a message for Mr. Waer to call me since I had questions concerning the list provided to me in his e-mail. (14:30) Mr. Waer called me back. I noted that the third column under "Item" either says "LPA-1" or "Resource." I asked Mr. Waer if that meant the devices marked resource had been received by the company and exchanged out for generally-licensed device. Mr. Waer stated that was not the case. The devices had been received by RMD, resourced, but not made generally-licensed because, at the time, RMD was not aware of the changeover of NARM to the NRC. I thanked Mr. Waer and stated that we would be issuing a clear inspection letter as well as updates on the NRC's efforts to contact the companies on the list.

Action Required: Document for the inspection.
