DECLARATION OF PAMELA MACKEY TAYLOR

PAMELA MACKEY TAYLOR, declares as follows:

- 1. I am the Conservation Chair for the Iowa Chapter of the Sierra Club. As Conservation Chair, I know that the Sierra Club has long opposed nuclear power because it is dangerous and harmful to the environment. More recently, the Sierra Club has advocated for transitioning to renewable energy sources and energy efficiency as the path to a clean and sustainable energy future. Nuclear power does not help to achieve this goal.
- 2. The Iowa Chapter has voted to endorse and support the petition to intervene and request for hearing filed by the Sierra Club with the Nuclear Regulatory Commission regarding the Fort Calhoun Nuclear Station. The Iowa Chapter has approximately 110 members who live in Harrison and Pottawattamie Counties, within 50 miles of the Fort Calhoun reactor, who own property and recreate in the area and who risk exposure to radiation from Fort Calhoun, affecting their health and safety, adverse impacts to the ecosystem, and diminished property values, from possible radiation leaks.

- 3. I have personally been involved in monitoring the status of the Fort Calhoun reactor since the reactor was flooded in June of 2011. I have attended almost every public meeting conducted by the NRC involving Fort Calhoun since June of 2011. I am therefore aware of, and concerned about, the many safety-related problems at Fort Calhoun that were uncovered after the reactor was flooded in June of 2011. I am especially concerned that some of the most significant problems have not been adequately addressed. That is why the petition filed by the Sierra Club is so important.
- 4. On behalf of the Iowa Chapter, I request that the Nuclear Regulatory Commission hold a public hearing regarding the petition filed by the Sierra Club.

DECLARATION OF CANDY BLESS

- 2. The Nebraska Chapter has voted to endorse and support the petition to intervene and request for hearing filed by the Sierra Club with the Nuclear Regulatory Commission regarding the Fort Calhoun Nuclear Station.
- 3. I personally live within 35 miles of the Fort Calhoun reactor. I am aware of, and concerned about, the many safety-related problems at Fort Calhoun that were uncovered after the reactor was flooded in June of 2011. I am especially concerned that some of the most significant problems have not been adequately addressed. That is why the petition filed by the Sierra Club is so important.
- 4. The safety risks inherent in the situation at Fort Calhoun include flooding of the Missouri River, inadequate structural conditions at Fort Calhoun, and improper operation of the reactor. These risks affect my health, the use and enjoyment of my property, and

the environment in and around Omaha. I am deeply concerned about these risks.

5. I request that the Nuclear Regulatory Commission hold a public hearing regarding the petition filed by the Sierra Club. I authorize Sierra Club to request a hearing on my behalf, and to represent my interest in such a proceeding, as well as any litigation pertaining to this issue.
