This is to document the agency's periodic review of RG 1.111, Revision 1, "Methods for Estimating Atmospheric Transport and Dispersion of Gaseous Effluents in Routine Releases from Light-Water-Cooled Reactors." The RG dates to 1977. As discussed in Management Directive 6.6 "Regulatory Guides," the NRC staff reviews regulatory guides approximately every five years to ensure that the guides continue to provide useful guidance.
