**List of Approved Spent Fuel Storage Casks: HI-STORM 100 Cask System; Amendment No. 9; Corrections: Final Rule; Correcting Amendment; 10 CFR Part 72 (RIN 3150-AJ12; NRC-2012-0052)**

On April 14, 2014, the NRC published a correcting amendment in the *Federal Register* ([79 FR 20753](#)) correcting a direct final rule published in the *Federal Register* on December 6, 2013 ([78 FR 3379](#)). The direct final rule amended the NRC's spent fuel storage regulations by revising the Holtec International HI-STORM 100 Cask System listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 9 to Certificate of Compliance (CoC) No. 1014. On December 26, 2013 ([78 FR 78165](#)), the NRC published a document that corrected several Agencywide Documents Access and Management System accession numbers referenced in the direct final rule and delayed the effective date of the direct final rule from February 19, 2014, to March 11, 2014. This correcting amendment was necessary to provide notification that the NRC amended its regulations by revising the Holtec HI-STORM 100 Cask System listing within the "List of Approved Spent Fuel Storage Casks" to correct the effective date of Amendment No. 9 to CoC No. 1014.

**Revision of Fee Schedules; Fee Recovery for Fiscal Year 2014: Proposed Rule; 10 CFR Parts 170 and 171 (RIN 3150-AJ32; NRC-2013-0276)**

On April 14, 2014, the NRC published a proposed rule in the *Federal Register* ([79 FR 21036](#)) proposing to amend the licensing, inspection, and annual fees charged to its applicants and licensees. The proposed amendments are necessary to implement the Omnibus Budget Reconciliation Act of 1990, as amended, which requires the NRC to recover through fees approximately 90 percent of its budget authority in fiscal year 2014, not including amounts appropriated for Waste Incidental to Reprocessing and amounts appropriated for generic homeland security activities. These fees represent the cost of NRC services provided to applicants and licensees. Comments on the proposed rule are due by May 14, 2014.

**List of Approved Spent Fuel Storage Casks: Transnuclear, Inc. Standardized Advanced NUHOMS<sup>®</sup> Horizontal Modular Storage System; Amendment No. 3: Direct Final Rule; 10 CFR Part 72 (RIN 3150-AJ31; NRC-2013-0271)**

On April 15, 2014, the NRC published a direct final rule in the *Federal Register* ([79 FR 21121](#)) amending its spent fuel storage regulations by revising the Transnuclear, Inc. Standardized Advanced NUHOMS<sup>®</sup> Horizontal Modular Storage System (NUHOMS<sup>®</sup> Storage System) listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 3 to Certificate of Compliance No. 1029. Amendment No. 3 adds a new transportable dry shielded canister to the NUHOMS<sup>®</sup> Storage System and makes editorial corrections. The companion proposed rule was published in the *Federal Register* on April 15, 2014 ([79 FR 21156](#)). Unless significant adverse comments are received by May 15, 2014, the direct final rule will become effective on June 30, 2014.
