Mr. Kent,

We have received your request dated December 9, 2013, to update all of your records regarding your company SEE Co., Inc. We verified the information submitted and concluded the following:

- The distributor name and address on the registration certificate NR-1112-S-101-S needs to be updated to reflect the name and address as shown in your license No. 1161-201-27 issued by the State of Minnesota. You will need to indicate if the name change is as a result of a change of control/ownership or just a name

change. If this change is as a result of a change of control/ownership, please provide the information listed in Section 13.6 of Volume 3 of the NUREG 1556 series. The document is accessible on the NRC web site at www.nrc.gov. My office will make the change in your sealed source and device (SS&D) registration certificate NR-1112-S-101-S.

- Regarding registration certificate TX-1112-S-101-S, you need to (1) request, from the NRC in a formal communication, the transfer of the registration certificate to the NRC and (2) request separately, from the State of Texas, an inactivation of the registration issued by the State of Texas. Please note that we may be able to combine the two registration certificates into a single registration with the NRC. If you wish to combine both registration certificates you will need to demonstrate that the products are essentially identical in design, function, and construction and that only vary in a dimensional capacity, in the sources used, or in the application. Please provide this information to us. For further guidance on what type of products could be registered in one registration, please see Section 10.1 (Page 10-3, Paragraph 3) in NUREG-1556, Vol. 3, Rev. 1, "Consolidated Guidance about Materials Licenses: Applications for Sealed Source and Device Evaluation and Registration". We also ask you to submit the documents to us which are referenced in TX-1112-S-101-S, so that the NRC would have a full set of records.
