Discussion: I questioned Mr. Otero about the difference in the name of the company on the license and the April 17, 2014, letter; the difference in the mailing address on the NRC Form 313 and the letter; and whether the he had the authority to sign requests to amend the license. (1) Mr. Otero explained that VHB was short-hand for the official name of the company "Vanasse Hangen Brustlin, Inc." In future requests, he would refrain from using the short-hand version of the name of the company. (2) Mr. Otero stated that Item 2 of NRC Form 313 misidentifies the mailing address as 14 Industrial Park Place, Middletown, CT instead of 100 Great Meadow Road, Wethersfield, CT as stated in the April 17, 2014, letter. The Wethersfield address is the corporate offices. (3) Robert Christman has given him the authority to make any changes needed in the license; however, there is nothing in writing. Mr. Otero stated that such a document would be drafted and placed on file for future inspection by the NRC. I thanked Mr. Otero for the information and stated that I would call him to provide advance notice of when the completed license would be faxed to him.
