**Environmental Impacts of Spent Fuel Storage During Reactor Operation: Petition for Rulemaking; Acceptance and Docketing; 10 CFR Part 51 (PRM-51-31; NRC-2014-0055)**

On May 1, 2014, the NRC published a document in the *Federal Register* ([79 FR 24595](#)) regarding acceptance and docketing of a petition for rulemaking (PRM) from Diane Curran on behalf of 34 environmental organizations (the petitioner), dated February 18, 2014. The petitioner requests that the NRC revise its regulations and consider in all pending and future reactor licensing, and relicensing decisions, new and significant information bearing on the environmental impacts of high-density spent fuel storage in reactor pools and the costs and benefits for avoiding or mitigating those impacts. The NRC is not instituting a public comment period for this PRM at this time.

**Publication of Draft Regulatory Guide (DG) - 1310, "Medical Evaluation of Licensed Personnel for Nuclear Power Plants"**

On April 25, 2014, the staff released DG-1310, "Medical Evaluation of Licensed Personnel for Nuclear Power Plants," (proposed Rev. 4 to RG 1.134) to provide the public an opportunity to comment on the proposed revision of the Regulatory Guide. This revision to RG 1.134 is being issued to endorse the 2013 revision of the consensus standard, ANSI/ANS 3.4, "Medical Certification and Monitoring of Personnel Requiring Licenses for Nuclear Power Plants." The guide helps to ensure that medical certifications (and related medical evidence) are sufficient. The DG is publicly available in Agencywide Documents Access & Management System Accession No. ML13352A278.

**National Operator Licensing Examiners Conference**

On April 22-24, 2014, staff participated in the National Operator Licensing Examiners Conference hosted by Region IV. This biennial conference served as a forum to discuss challenges and experiences related to operator licensing examination development and administration and requalification inspections and to reinforce expectations for consistent administration of the program across the regions using the examination standards contained in NUREG-1021, "Operator Licensing Examination Standards for Power Reactors." After opening remarks from senior management, discussions on specific operator licensing topics were led by each of the regions and the headquarters program offices. There was open and active participation by the attendees, which also included two staff members from the Canadian Nuclear Safety Commission who presented information on the Canadian approach to simulator examinations and changes to operator training in response to the Fukushima Dai-ichi nuclear power plant accident.
