RESOLUTION OF THE BOARD OF DIRECTORS OF THE HI-DESERT WATER DISTRICT SUPPORTING LICENSING SAN ONOFRE UNITS II AND III NUCLEAR POWER PLANTS

WHEREAS, Hi-Desert Water District is vitally concerned that the economic, environmental and social well-being of the State of California be maintained; and

WHEREAS, an adequate supply of energy is critical to meeting California's economic and social needs while preserving the environmental gains of the past decade; and

WHEREAS, this nation's continued overdependence on foreign oil has caused major adverse economic impacts; and

WHEREAS, there is a probability that instability in the Middle East will, at some near future time, result in reduced supplies of oil, thereby causing further social and economic chaos here at home; and

WHEREAS, regulatory delays in the planning and licensing of needed energy facilities are costly to the consumer, damaging to the environment, and result in greater importation of foreign oil;

NOW, THEREFORE BE IT RESOLVED, that Hi-Desert Water District supports

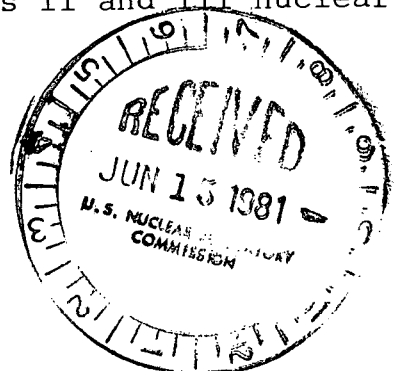
