What is the Waste Confidence rule and DGEIS?

The Waste Confidence rule is the NRC's generic determination of the environmental impacts associated with the storage of spent nuclear fuel after the end of a reactor's licensed life for operation. The Waste Confidence DGEIS describes the environmental impacts of continuing to store spent nuclear fuel beyond the licensed life for operation of a reactor. The DGEIS is the regulatory basis for the proposed rule.

Why are we sending them to you?

The NRC is asking for comments on the proposed rule and DGEIS. If you would like to comment on the documents, please submit your comments by November 27, 2013, to ensure their consideration. Comments submitted after this date will be considered as practicable.
