SUBJECT:	FERMI UNIT 3 COMBINED LICENSE APPLICATION – SAFETY EVALUATION WITH NO OPEN ITEMS FOR CHAPTER 1, "INTRODUCTION AND INTERFACES"			

By letter dated September 18, 2008, DTE Electric Company submitted an application to the U.S. Nuclear Regulatory Commission (NRC) for a combined license (COL) for Fermi 3.

Based on our review of the application, the staff is providing the Advisory Committee on Reactor Safeguards (ACRS) its Safety Evaluation (SE) with no open items for Chapter 1, "Introduction and Interfaces" (ADAMS Accession No. ML14080A144). Unless otherwise stated in the SE, the staff's review was based on Revision 6 of the application. The SE is being provided to support a meeting of the subcommittee of the ACRS scheduled for July 7, 2014. The ACRS Full Committee meeting will be held after the subcommittee meeting.

In accordance with the memorandum to the ACRS dated March 17, 2010 (ADAMS Accession No. ML100700612), the staff has reviewed the submitted information against the categories for which the ACRS requested be used to highlight information for review by the committee. The staff's assessment of this chapter is that there are no items that meet the categories for discussion with the committee.
