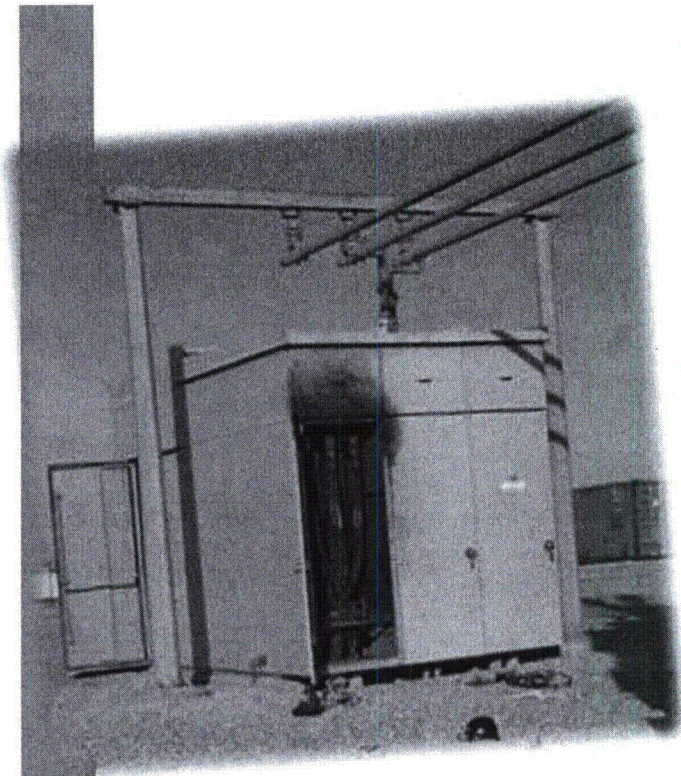

**Subject:** Refuel 19 Start Delayed 48 Hours



After much review, we have decided to delay the start of Refuel 19 by 48 hours to allow for the resolution of several issues and to ensure we are ready to safely execute our outage plan. Most notable is the repair of the Safeguards Switchgear 13.8 KV Circuit Breaker MD52-4, the completion of pre-outage work and ensuring all necessary support personnel are returned to work after our safety stand down. We will now begin shutting down the plant at 2300 on Sunday, April 7<sup>th</sup>.

The Outage Control Center and the outage organization will be staffed at 1000 today to drive site readiness and breaker repair.

Work to repair the power source to our outlying support buildings is scheduled to complete on Saturday evening, restoring power to the Central Processing Facility, Callaway Multipurpose Building, Sally Port, and other affected areas.

As of this morning, all Chicago Bridge and Iron (CB&I) workers have returned to site and their regular scheduled activities.

We greatly appreciate your patience and understanding over the last 2 days as we have worked diligently to review our current status of work and ensure we make the appropriate conservative decision for our station. We still have much work to complete to be prepared to safely execute our outage per the schedule. Please remain focused on safety and the task at hand as we work to recover from the events of the last few days.
