The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2013-012) on February 21, 2013, to determine whether a Security Officer at Peach Bottom Atomic Power Station (PBAPS) was discriminated against for having raised safety concerns. Based upon documentary and testimonial evidence developed during the OI investigation, there was insufficient evidence developed for the NRC to substantiate that the PBAPS Security Officer was discriminated against for having raised safety concerns.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA. Requests under the FOIA should be made in accordance with 10 CFR 9.23, Requests for Records, a copy of which is enclosed for your information.
