## RE: Indian Point Annual Assessment Meeting 5/4/2014

Dear Chairman MacFarlane:

It is with a total lack of respect for the public stakeholders the NRC and Entergy have moved the location of the annual NRC assessment meeting back to Cortland Manor, which is inaccessible by public transportation, has limited parking and access.

In addition to moving the only public stakeholder meeting the NRC continues fail to require transcription or recording of the public portion of the meeting, thereby preventing the Commissioners and other NRC staff to consider the input of public stakeholders regarding operations of Indian Point 2 and 3 reactor where many serious safety and security issues remain unresolved. Indian Point 2 is the only reactor in the nation operating without a license, and that the NRC has identified it to be the reactor most at risk from seismic activity therefore the NRC has an obligation to provided adequate and meaningful public stakeholder participation as required by the Atomic Energy Act.

Therefore we respectfully request that the NRC Commissioners require the Indian Point annual assessment meeting to be relocated to Tarrytown, where it has been held for the past few years, which is centrally located and accessible to the public stakeholders in the largest reactor community in the nation.

In addition, we once again respectfully request transcription or recording of the public portion of the meeting where important information regarding ongoing leaks,

fire safety violations, security violations and spent fuel issues will be presented.
