SUBJECT: UPDATE OF SECTION 106 CONSULTATION AND AVAILABILITY OF FIELD DOCUMENTATION OF POTENTIAL PLACES OF TRIBAL RELIGIOUS OR CULTURAL SIGNIFICANCE AT THE CROW BUTTE MARSLAND EXPANSION AREA PROJECT SITE

Dear Mr. Breast:

The U.S. Nuclear Regulatory Commission (NRC) is responsible for the government-to-government consultation with respect to the renewal of operating license SUA-1534 for the Cameco Resources, Inc. (Cameco) Crow Butte in-situ uranium recovery (ISR) facility and the three proposed expansion areas: North Trend Expansion Area (NTEA); Marsland Expansion Area (MEA); and, Three Crow Expansion Area (TCEA). The purpose of this letter is to provide your office with an update of ongoing consultation activities in accordance with Section 106 of the National Historic Preservation Act (NHPA) for the proposed MEA.

On April 2, 2013, the NRC provided your office with a copy of the Traditional Cultural Properties (TCP) Survey report completed by the Santee Sioux Nation and the Crow Nation for the proposed Crow Butte projects. The TCP Survey report summarized the findings from the Tribal field inventory of the operating ISR facility, the MEA, and the TCEA, identifying 13 places of cultural significance to the tribes. The report determined that none of the 13 places was potentially eligible for listing on the National Register of Historic Places (NRHP). The report also offered recommendations for a buffer zone around each of the 13 identified places to avoid impacts during future project activities, and for one or two Tribal monitors to be stationed at each identified site within the Marsland project area should any future impacts occur in close proximity. The Tribal report included location data for each of the 13 identified places, along with a label designating potential function or cultural value.

While NRHP recommendations were offered in the TCP Survey report, supporting documentation for those evaluations was not included. Therefore, to provide the necessary documentation of the identified sites for NRHP determinations, the NRC sent a cultural resources expert to revisit the surveyed area, locate each of the 13 places identified by the Crow and Santee Sioux Nations, and complete standard cultural site documentation for each place. This cultural resources expert was present during the initial tribal survey with the Crow Nation and the Santee Sioux Nation and was able to relocate the 13 places identified by the tribes. The cultural resources expert completed the field visit and produced a field survey report which provides additional details to accompany the Crow and Santee Sioux Nations' interpretation of each identified site.
