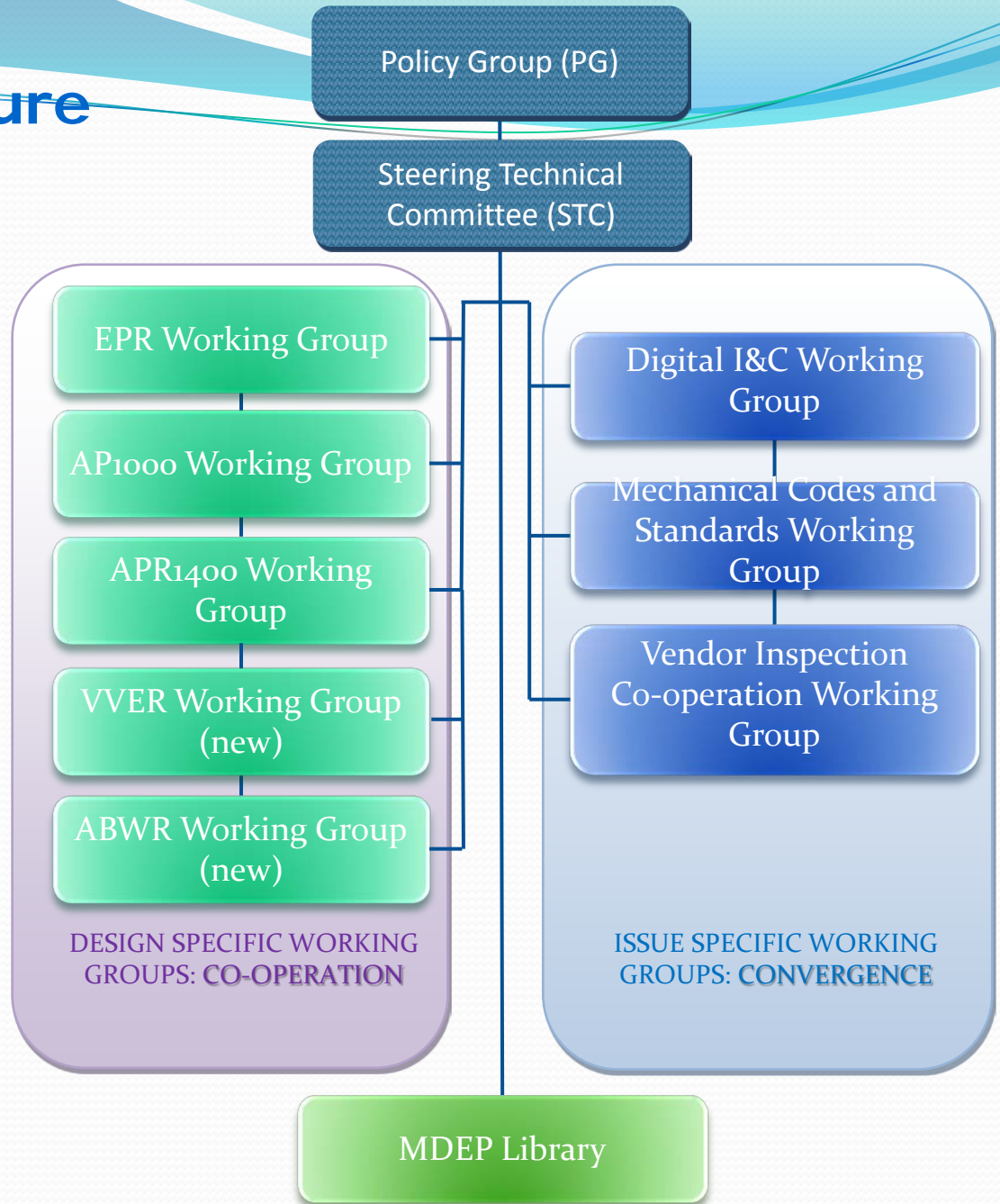

# VICWG Objectives

- To leverage inspection resources
- To understand Quality Assurance/Management (QA/QM) Requirements for MDEP countries
- To facilitate good practices
- To harmonize the vendor inspection practices
- To continue joint and witnessed inspections and perform multinational inspections

# MDEP Protocol

## VICWG-01

### **Purpose and Scope**

- The purpose of this protocol is to provide guidance to regulators that wish to carry out vendor inspections or participate in or witness other regulators' vendor inspections or to conduct multinational inspections. It also provides guidance for the sponsoring regulator with regard to its interactions with inspecting, witnessing or participating regulators.

# Current Inspection Types

- **Witnessed inspection** – an activity in which a regulator conducts an inspection according to its own regulatory framework and one or more regulators witnesses it.
- **Joint inspection** – an activity in which one regulator conducts an inspection according to its own regulatory framework with the participation of one or more other regulators' inspectors.

# Multinational Inspection

- An inspection performed by multiple regulators to the VICWG Common QA Requirements
- Requires leadership by one country and technical support from participating inspectors
- Pilot – Valinox Nucléaire, July 2014

# Key Logistical Issues

- Inspection table maintained on the MDEP website
- Sponsoring Regulator determines language
- Records governed by Sponsoring Regulator
- Witnessing regulators provide feedback to MDEP library



# VICWG Inspections

- 2011 - 7 witnessed inspections and 1 joint inspection
- 2012 - 7 witnessed inspections and 1 joint inspection
- 2013 - 12 witnessed inspections and 1 joint inspection

# Benefits

- Regulators
  - Greater Ability Understand the Results of Foreign Inspections
  - The ability to Prioritize Inspections Based on Foreign Inspections
  - The Ability to Leverage Foreign Inspectors
  - Increased Communication Regarding Vendor Issues
- Vendors
  - Reduced Inspections Because Regulators are Sharing Results
