(RG) 3.48

This memorandum documents the US Nuclear Regulatory Commission (NRC) periodic review of RG 3.48, "Standard Format and Content for Safety Analysis Report (SAR) for an Independent Fuel Storage Installation or Monitored Retrievable Storage Installation (Dry Storage)." RG 3.48 describes methods applicable to submitting guidance on the content of the SAR, depending on the type of installation that is planned.

As discussed in Management Directive 6.6, "Regulatory Guides," the NRC staff reviews RGs approximately every 5 years to ensure that the RGs continue to provide useful guidance. Documentation of the NRC staff review is enclosed.

Based on the results of the periodic review, the staff plans to withdraw RG 3.48 after publication of Rev. 1 of RG 3.62, "Standard Format and Content for the Safety Analysis Report for Onsite Storage of Spent Fuel Storage Casks". The staff anticipates it will be withdrawn by the end of 2015.
