On May 2, 2014, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Oyster Creek Nuclear Generating Station. On May 16, 2014, the NRC inspectors discussed the results of this inspection with Mr. Timothy Keenan, Manager, Site Security, and other members of your staff. Inspectors documented the results of this inspection in the enclosed inspection report.

NRC inspectors documented one finding of very low security significance (Green) in this report. This finding involved a violation of NRC requirements. If you contest this violation or the significance of this non-cited violation (NCV), you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001; with copies to the Regional Administrator, Region I; the Director, Office of Enforcement, U.S. Nuclear Regulatory Commission, Washington, DC 20555-0001; and the NRC resident inspector at the Oyster Creek Nuclear Generating Station.

One cross-cutting aspect was assigned to the finding in the area of Human Performance. The cross-cutting aspect was assigned in the area of Human Performance, Resources, because Exelon did not ensure that procedures were adequate to support nuclear security (H.1). If you disagree with the cross-cutting aspect assignment in this report, you should provide a response within 30 days of the date of this inspection report, with the basis for your disagreement, to the Regional Administrator, Region I; and the NRC resident inspector at the Oyster Creek Nuclear Generating Station.
