On behalf of United Nuclear Corporation (UNC), Chester Engineers is submitting electronic copies of the input files for the numerical groundwater flow model (Flow Model) of UNC’s Church Rock Mill and Tailings Site and the adjacent down-gradient region northeast of Gallup, New Mexico. The files are submitted for use by the United States Nuclear Regulatory Commission (NRC), per NRC’s June 4, 2013, Request for Additional Information (RAI) related to UNC’s April 2012 license amendment request.

The data files comprise the two simulations used to prepare the Flow Model report: the model simulation through 2011 and the model simulation through 2026. The data files were created for use by the Groundwater Modeling System software (GMS, version 5, Aquaveo publ.) and therefore do not follow NRC file naming conventions and are not provided in Adobe Portable Document Format (i.e., pdf). A few of the data files are also larger than 50 MB and cannot be segmented into smaller files. This transmittal and a file containing model file notes are provided as pdfs.

The files are transmitted on Optical Storage Media (OSM). The enclosure to this letter is one Digital Versatile Disc (DVD) containing the document components identified below.
