Discussion:

I called Mr. Lewis to request information regarding the Kuraray America, Inc. NRC license application. I asked Mr. Lewis to provide the model numbers of the gauges requested and to verify that the amount of activity requested was adequate to conduct their operations. I informed him that they should consider requesting enough additional activity for extra gauges if they anticipate gauge replacement activities to involve additional gauges being under their control during the process. I also asked Mr. Lewis if the gauges and the licensed program are still being implemented by the E.I. DuPont company (NRC License No. 47-01876-01) and Mr. Lewis stated that the gauges and the licensed gauge program will remain under the control of E.I. DuPont until Kuraray America, Inc.'s NRC license is issued. I asked Mr. Lewis if the employees and management had changed since the business unit was purchased from DuPont, he said the employees, management, and the process remain unchanged under the new owner and stated that the proposed RSO is a long-time employee of E.I. DuPont at the site. Lastly, I asked Mr. Lewis to provide copies of the company's business license, environmental permits, and any other official government documentation for the purpose of verifying the company is a legitimate entity. He said he would provide the information.
