SUBJECT: COMPLETION OF THE NATIONAL HISTORIC PRESERVATION ACT SECTION
106 CONSULTATION FOR THE NORTH ANNA POWER STATION UNIT 3
COMBINED LICENSE APPLICATION REVIEW

Dear Mr. Kirchen:

The purpose of this letter is to document completion of the Section 106 of the National Historic Preservation Act (NHPA) of 1966, as amended, consultation between the U.S. Nuclear Regulatory Commission (NRC) and the Virginia Department of Historic Resources (VDHR). In a letter dated February 3, 2009, the VDHR concurred with the "Draft Supplemental Environmental Impact Statement for the Combined License (COL) for North Anna Power Station Unit 3," determination of no adverse effect for historic properties. That letter is enclosed and can also be found through the NRC's Agencywide Document Access and Management System (ADAMS), which can be found at <http://www.nrc.gov/reading-rm/adams.html>, under accession number ML096050462. In February 2010, the NRC staff issued the COL final supplemental environmental impact statement (FSEIS) for North Anna Power Station, Unit 3.

By letter dated February 1, 2011 (ML110030219), the NRC staff notified VDHR of its intent to prepare a supplement to the COL FSEIS based on Dominion Virginia Power's (Dominion) decision to change to a different reactor design. Because the NRC would be supplementing the COL FSEIS, the NRC requested to reinstate consultations under NHPA.

After VDHR's letter of concurrence to NRC dated February 3, 2009, of no adverse effect for historic properties, Dominion continued to consult with VDHR on historic properties. By letter dated October 5, 2011 (ML11298A131), VDHR stated that Dominion's letter of September 11, 2011 (ML14175A297), accurately summarizes the consultation and commitments made to protect historic properties. The NRC's NHPA Section 106 finding, no adverse effect, is the same as in the above documentation.

By letter dated April 25, 2013 (ML13120A016), Dominion notified the NRC of its decision to return to the same reactor design as was referenced in the COL FSEIS; therefore, the NRC will not be preparing a supplemental environmental impact statement based on Dominion's change in reactor design. As the purpose for the reinstating of consultations no longer exists, the staff would like to confirm VDHR's concurrence with the finding of no adverse effect to historic properties and that NHPA Section 106 consultation is complete.
