This is to provide you an update on your above referenced petition, which was submitted on March 5, 2014. In your petition, you raised several concerns with equipment failures at Palisades Nuclear Plant (PNP) and requested number of actions to be taken by NRC and Entergy, the licensee at Palisades. On March 14, 2014, your request for immediate action to prevent Palisades restart was reviewed by the members of the Petition Review Board (PRB), which includes staff from the NRC's Office of Nuclear Reactor Regulation (NRR), staff from Region III, and the NRC resident inspectors at Palisades. After thorough review and discussions, the PRB reached a general consensus that there were no safety significant concerns to prevent the plant from restarting as scheduled. On April 8, 2014, you addressed the Petition Review Board (PRB) to provide additional information regarding this petition. The transcript of this call was added to Agencywide Documents Access and Management System (ADAMS) as a publicly available document (ADAMS Accession No. ML14142A101). On May 21, 2014, you sent an email providing additional information regarding the petition. The email was considered as supplemental information and was also added to ADAMS as a publicly available document (ADAMS Accession No. ML14142A101). The PRB continues to review your petition to develop an initial recommendation. The target date to complete the petition is 9/30/14. Thanks
