In response to your May 28, 2014, memorandum, the Office of Nuclear Security and Incident Response (NSIR) is providing feedback to the Committee to Review Generic Requirements (CRGR) regarding CRGR's informal review of a Regulatory Information Summary (RIS) 2013-19, "Removal of Safeguards Information Designation From Attachment 2 to Order EA-02-0261, 'Order for Compensatory Measures Related to Access Authorization'." (Agencywide Documents Access & Management System Accession ML13150A135). NSIR was supported by the Office of Nuclear Reactor Regulation and the Office of New Reactors in this effort.

RIS-2013-19 was a follow up action to a March 20, 2013, letter to licensees advising them of the removal of the Safeguards Information designation from Attachment 2 to Order EA-02-0261. On December 2, 2013, the CRGR Program Manager notified CRGR members that a quorum of the CRGR members have responded. The members indicated that they had not identified any backfit issues or concerns in their review of proposed RIS. Based on this notification, the CRGR Chairman finalized CRGR action on the proposed RIS, and the CRGR supported issuance of the information RIS.

The CRGR added value by assuring there were no new positions or requirements being imposed on licensees and applicants, and that no backfit was required. The CRGR's expeditious consideration of the proposed RIS ensured there was no impact either to the schedule or to staff resources.
