CONCERNING REQUEST FOR ALTERNATE DECOMMISSIONING
SCHEDULE, CONTROL NO. 581663**

Dear RDML Slates:

This is in reference to your letter dated August 9, 2013, requesting an alternate decommissioning schedule for the Naval Postgraduate School (PGS) in Monterey, California, permitted under NRC Master Materials License No. 45-23645-01NA. As discussed with Dr. Lino Fragoso on June 18, 2014, we need the following additional information or clarifications in order to continue our review.

1. Please clarify whether you are requesting a delay in initiating decommissioning activities in accordance with 10 CFR 30.36(f) or an extension in submitting a decommissioning plan in accordance with 10 CFR 30.36(g)(2).
2. Please advise if a decommissioning plan will be required for the PGS.
3. Please provide a discussion of the extent and nature of contamination and the potential by airborne or ground water pathways.
4. Please provide the length of the postponement requested and the estimated date of completion of decommissioning activities.
