In accordance with 10 CFR 50.54 (w)(3), Carolina Power & Light Company (CP&L) hereby submits information regarding the present level and source of on-site property damage insurance at the Brunswick Steam Electric Plant, Unit Nos. 1 and 2, the H. B. Robinson Steam Electric Plant, Unit No. 2, and the Shearon Harris Nuclear Power Plant.

CP&L has in full force and effect with Nuclear Mutual Limited primary nuclear property insurance for each reactor site in the amount of \$500,000,000 which expires April 1, 1995. This coverage is being renewed effective April 1, 1995, for the period April 1, 1995, to April 1, 1996.

CP&L also has in full force and effect with Nuclear Electric Insurance Limited for each reactor site excess nuclear property insurance in the amount of \$1,400,000,000 covering the period November 15, 1994, to November 15, 1995. This coverage is being renewed effective November 15, 1995, for the period November 15, 1995, to November 15, 1996.
