Sir or Madam:

The purpose of this letter is to transmit for information Revision 14 to the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2 Offsite Dose Calculation Manual (ODCM). The ODCM, section 9.1.6, requires that the Radiological Effluent Release Report include any changes to the ODCM that occurred during the reporting period. The ODCM was revised in its entirety to accommodate requirements relocated from Technical Specifications in accordance with the license condition contained in Appendix B to the Final Operating License, Amendment 176, dated October 24, 1997. The 1997 Radioactive Effluent Release Report, which was transmitted to the NRC by letter dated May 1, 1998, stated that a copy of the revised ODCM would be provided to the NRC under separate letter. Therefore, this letter transmits Revision 14 of the ODCM in accordance with the ODCM Section 9.1.6 requirement
