Dear Mr. Deale:

It was my pleasure to represent Governor McNair and the South Carolina State Development Board at the hearing on the above subject at the Darlington, South Carolina City Hall on Tuesday, March 28, 1967. The following information is offered to you as Chairman for this hearing for your records.

A copy of the Governor's report on Amendments Nos. 6 and 7 is attached. As reported by me, my office was requested by the Governor to review the technical aspects of Carolina Power and Light's application for construction of the above nuclear electric generating station. I have been assisted in this review by Mr. Robert C. Blair, former Manager, Savannah River Operations Office, U.S. Atomic Energy Commission, Savannah River Plant. Mr. Blair now serves my office within the State Development Board as a Consultant for atomic energy matters.

The two of us have diligently surveyed the pertinent literature relating to the construction of H. B. Robinson Unit No. 2 and also the other relevant matters pertaining to the geology, safety, and other qualities applicable to this generating station. We are very favorably impressed with the technical expertise employed to render information on this station. They have pursued their exhaustive studies diligently with respect to safety, construction, and operation of the unit, and their reports leave nothing for us to question as to the suitability of the structures for their prospective uses.


We are pleased to have Carolina Power and Light Company initiate work which will enhance the private atomic energy resources of South Carolina, and are of the opinion that their new generating station will assist us greatly in promoting the industrial expansion of our state in this important new field of atomic energy.

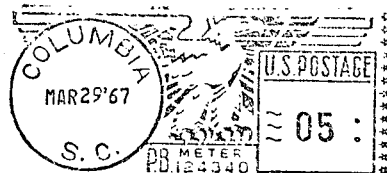
