Summary

Carolina Power and Light Company's (CP&L) letter to you (Serial: NLS-87-145), dated July 10, 1987, responded to the subject inspection report. Due to the increased scope of actions required to implement the program in response to Inspection Follow-Up Item 50-261/87-06-18, it has become necessary to reschedule our commitment for final implementation. This matter was discussed with Mr. P. Fredrickson of your staff on November 25, 1987.

Details

As stated in the subject letter, a methodology for indexing calculations at Robinson Plant was established by August 31, 1987. Our intent, however, to have an approved, functioning program by November 1, 1987, by which current, approved calculations related to the Robinson Plant design could be included in the index, is incomplete at this time. At this stage, a computer program has been developed to index the calculations and several hundred calculations have been entered. A draft procedure, which will capture new calculations for entry, has been developed by the Nuclear Engineering Department (NED). NED has primary responsibility for developing and controlling the majority of calculations within CP&L. Other organizations within CP&L, however, provide design affecting calculations other than NED. The participation of these

other organizations' is being solicited and their approval of this program will be required. The incorporation of these other organizations requires more time than previously expected.
