SUBJECT: NOTICE OF VIOLATION NRC INSPECTION REPORT NO. 50-261/90-11

This refers to the Nuclear Regulatory Commission (NRC) inspection conducted by L. W. Garner on April 11 - May 10. The inspection included a review of activities authorized for your H. B. Robinson facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed inspection report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

The inspection findings indicate that certain activities appeared to violate NRC requirements. The violation, references to pertinent requirements, and elements to be included in your response are described in the enclosed Notice of Violation.

The violation described in the enclosed Notice is similar to a violation contained in the Notice sent to you by our letter dated June 23, 1988. Recurring violations are of particular concern because the NRC expects licensees to learn from their past failures and to take effective corrective actions. Although NRC does not normally consider monetary civil penalties for Severity Level IV violations, the Enforcement Policy states that such penalties may be imposed for Severity Level IV violations that are similar to previous violations for which the licensee did not effective corrective action. In this case, we have decided not to hold an enforcement conference nor to propose a civil penalty because of the safety significance associated with not performing monthly surveillance testing of the identified instrument logic channels, actions taken to assure the monthly testing of the power range high flux - low setpoint and two-out-of-three loop low flow reactor trip logic channels and your proposed actions associated with testing the intermediate and source range reactor trip logic channels.

In your response to the enclosed Notice, you should document the specific actions taken and any additional actions you plan to prevent recurrence of inadequate surveillance testing of Technical Specification required instrumentation. We will review your response, including your proposed corrective actions, and the results of future inspections to determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.

In accordance with Section 2.790(a), a copy of this letter and its enclosures will be placed in the NRC Public Document Room.

The responses directed by this letter and its enclosures are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, Pub. L. No. 96-511.
