SUBJECT: REQUEST FOR ADDITIONAL INFORMATION

Dear Mr. Wolfe:

This refers to your license renewal application request dated May 19, 2014 (Agencywide Documents Access and Management System (ADAMS) No. ML14148A430). Your application states that "Our processes and end products using Kr-85 have not changed since the current license was issued in 1994 and amended in 2013." We request that you resubmit the pertinent information in a new document.

The intention of this request is to have an up-to-date document that provides all of the information required by the regulations in Title 10, Code of Federal Regulations, Part 32 (10 CFR 32), sections 32.14 and 32.15. It is acceptable to reuse previously submitted documents as long as they are provided as attachments to a new document describing your current program. The new document should provide the answers to each of the questions in the enclosure to this letter, either as a statement within the new document itself, or by referring to an attached, previously-submitted document.

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your renewal application.

For future reference, please note that since items 7 through 11 of NRC Form 313 pertain to possession and use licenses and are not applicable to the exempt distribution license; applicants for an exempt-distribution license should only complete items 1 through 6, 12 and 13.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS).
