SUBJECT: UNITED STATES ENRICHMENT CORPORATION'S REQUEST FOR REVIEW OF PROPOSED ACTIONS FOR TERMINATION OF U.S. NUCLEAR REGULATORY COMMISSION CERTIFIED OPERATIONS AT THE PADUCAH GASEOUS DIFFUSION PLANT (TAC NO. L34292)

Dear Mr. Toelle:

The U.S. Nuclear Regulatory Commission's (NRC's) staff has reviewed your June 17, 2014, letter requesting NRC review of United States Enrichment Corporation's (USEC's) proposed actions to de-lease the NRC-certified facilities at the Paducah Gaseous Diffusion Plant (PGDP) in Paducah, Kentucky, and terminate USEC's operations at the site under the NRC Certificate of Compliance (CoC). Your letter is available via the NRC's Agencywide Documents Access and Management System (ADAMS), Accession Number ML14176A081.

In your letter, you stated that on June 17, 2014, the U.S. Department of Energy (DOE) and USEC signed a Framework Agreement (Agreement), which establishes a framework for the de-lease and return of all leased premises at PGDP to DOE. The Agreement establishes a return date as early as October 1, 2014, subject to conditions in the Agreement, the Turnover Plan, and all turnover requirements in the lease. You further stated that, in the event that the conditions are not fully met on October 1, 2014, the leased premises will be returned to DOE as quickly as possible after October 1, 2014, subject to the satisfaction of all conditions.

In your letter, you also stated that, in accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) Part 76.66, USEC proposes to send a notification to the NRC that USEC is terminating NRC-certified operations at PGDP in conjunction with the de-lease of all remaining USEC-leased facilities and that DOE, through its deactivation contractor, will be assuming operation and control of the current USEC-leased, NRC-certified facilities and operations. In this notification, USEC plans to address the following:

- The regulatory basis that will be in place to ensure a seamless transition of regulatory authority from NRC to DOE such that no gaps in the oversight of PGDP facilities exist. Documentation that DOE agrees to assume regulatory authority of all PGDP facilities when NRC's authority ends will be provided.
- Confirmation of uninterrupted control over source, byproduct and special nuclear materials in full compliance with the NRC-approved Fundamental Nuclear Material Control Plan during transition of regulatory oversight from NRC to DOE.
