SUBJECT: TECHNIWELD USA, REQUEST FOR ADDITIONAL INFORMATION  
CONCERNING APPLICATION FOR A NEW LICENSE

Dear Mr. Johnson:

This letter refers to your application dated May 24, 2014, and received by our office on June 9, 2014. In reviewing your application, we found that additional information is required.

10 CFR 40.52 requires the applicant to submit sufficient information regarding the product pertinent to evaluation of the potential radiation exposure. Therefore, please submit the following additional information:

1. Describe chemical and physical forms and maximum quantity of source material in each product;
2. Submit the details of construction and design of each product;
3. Submit the the proposed method of labeling or marking each unit, and/or its container with the identification of the manufacturer or initial transferor of the product and the source material in the product;
4. Describe the means of providing radiation safety precautions and instructions relating to handling, use, and storage of products to be used under § 40.13(c)(1)(i) and (c)(1)(iii).

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.

In accordance with 10 CFR 2.390 of NRC's "Agency Rules of Practice and Procedure," a copy of this letter and its enclosure will be available electronically for public inspection in the NRC's Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS).
