Dear Mr. Richard:

This refers to your application dated April 28, 2014, requesting change in the mailing address and storage location of licensed material as specified on your NRC license No. 28-35064-01.

Please note that the first two digits of an NRC license identify the State of the licensee's mailing address. The NRC policy requires that when a licensee changes its mailing address to another State, a new license with a new number (corresponding to the State of the new mailing address) must be issued to replace the existing license. Your mailing address was in the State of New Hampshire, and you requested to change it to a new address in the State of Vermont, therefore it became necessary to administratively terminate your license No. 28-35064-01, and concurrently issue a new license No. 44-35148-01, with mailing address in the State of Vermont. The conditions of your license and your commitments remain unchanged and are incorporated into the new license.

Enclosed with this letter are the terminated license and the new license.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
