I have a question: Refer to Page 8.3-28 of the updated Rev 7 – Interim version; Areva has deleted ""and power factors of 85% or less". We had earlier requested the reason for deleting it. They have not provided any reason so far.

According to RG 1.9, Under C. Regulatory Position, Page 5, Section 1.2, the power factor of 85% or less is provided as the characteristics of the emergency Diesel generators.

Please obtain a confirmation that they will not deviate from the RG 1.9 guidance.
