The U.S. Nuclear Regulatory Commission (NRC) staff is preparing an advanced final safety evaluation (AFSE) for each chapter of the Fermi Unit 3 Combined License Application submitted by DTE Electric Company on September 18, 2008.

The staff's AFSE for Chapter 2.5, "Geology, Seismology, and Geotechnical Engineering" is being provided to the Advisory Committee on Reactor Safeguards (ACRS) subcommittee to support an upcoming meeting of the ACRS subcommittee.
