Notice of Possible Sale of Assets to a New Entity without Any Change in Operations or Personnel

Dear Sir/Madam:

Century Inspection, Inc., a Texas corporation ("Century") is the holder of the above-referenced license. Century is in the process of negotiating the sale of substantially all of its assets to Century Inspection, Inc., a Delaware corporation ("Century II"). Century II is a wholly-owned subsidiary of Acuren Inspection, Inc. ("Acuren"), which is licensed to handle radioactive materials and equipment.

Details of the expected transaction are provided below. The current target date for the closing of the transaction is June 30, 2014, which would make July 1, 2014 the first day of Century II's operations.

We are writing to (1) provide advance notice of this possible transaction and (2) request your consent to Century II being permitted to operate under the above-referenced license after the closing. As noted below, this transaction will not result in any changes to Century's operations or personnel. Century II will have the same RSO, management, employees, procedures, facilities, vehicles and equipment that Century has today.

### Description of Transaction

The proposed transaction is an asset purchase of substantially all of Century's assets. Acuren created Century II as a new legal entity for the sole purpose of acquiring Century's business operations.

#### Personnel

All existing Century personnel, including management and supervisory personnel responsible for execution of Century's radiation safety program and radiographers, would be retained with no change in job duties. Century's current RSO, Drew H. McCorkle, will be the RSO of Century II.

## 3. Location, Equipment and Procedures

Century II's operations after closing would continue from existing facilities, using existing equipment and storage and use areas, and pursuant to existing operating, safety and emergency procedures. There will not be any changes in the use, possession, location or storage of licensed materials.

#### 4. Records

All records would remain in the possession of the same employees who are currently maintaining them for Century with no change in records storage or handling processes. Century's surveillance items and records will be current as of the closing date.

# 5. Century II's Commitment to Abide by All Existing Obligations

Century II would comply with all constraints, license conditions, requirements, representations and commitments identified in and attributed to the above-referenced license and registration. Century II will accept full responsibility for all future obligations and responsibilities relating to the license and registration.

### 6. Other Issues

Century would remain in existence and in good standing with the Texas Secretary of State until a new license was granted to Century II. Century does not have any open inspection, audit or similar issues.
