This is in response to Mr. Vernon J. Shanks' letter dated May 27, 2014 (ACO 14-0023), submitting changed pages of the Emergency Plan (EP) for the American Centrifuge Lead Cascade Facility to the U.S. Nuclear Regulatory Commission (NRC), pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) 70.32(i).

We have completed the review of the submitted changes. The NRC staff has determined that the changes to the EP were properly submitted, in accordance with 10 CFR 70.32(i), and are administrative in nature. The NRC staff also determined that the changes do not decrease the effectiveness of the plan and, therefore, are acceptable. As such, the changes to the EP are approved.

This action closes efforts under Technical Assignment Control Number L34290.
