Gentlemen:

This letter is submitted in response to a request by Mr. Brian Sheron, NRC, made at a meeting with the Westinghouse Owners Group on December 22, 1994, for utilities with Westinghouse mechanical steam generator tube plugs manufactured from Alloy 600 TT to perform an assessment of their integrity and suitability for continued operation.

The H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2 does not have any Westinghouse mechanical steam generator tube plugs manufactured from Alloy 600 TT that have not already been repaired or replaced. The only two plugs of this type that were installed were repaired using the "plug-in-plug" process in November 1990. The repair process utilized is considered to be a permanent repair in accordance with NRC Bulletin 89-01, "Failure of Westinghouse Steam Generator Tube Mechanical Plugs," and no further action is planned for HBRSEP.
