Gentlemen:

In accordance with 10 CFR 50, Appendix E, 10 CFR 50.54(q), and 10 CFR 50.4(b)(5), Carolina Power & Light (CP&L) Company transmits the enclosed revisions to the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2, Emergency Plan and Procedures.

CP&L has reviewed the changes to the Plan and determined that they do not decrease the effectiveness of the Plan and the Plan, as changed, continues to meet the standards of 10 CFR 50.47(b) and the requirements of 10 CFR 50, Appendix E. Noteworthy changes to the Plan include the inclusion of the new letters of agreement from Byerly Hospital and the Darlington County 911 Center, the change in the name of the former CP&L Meteorology Unit to Contract Meteorologic Personnel, as well as other minor changes to make the Plan consistent with the Emergency Procedures.
