In accordance with 10 CFR 50.54(q) and 10 CFR 50.4(b)(5), Carolina Power & Light (CP&L) Company transmits the enclosed revision to the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2, Emergency Plan. The effective date for the enclosed revision is October 27, 1995; therefore submittal of this revision is required by November 27, 1995. This revision replaces the previous revision in its entirety.

We have reviewed the changes to the Emergency Plan as described in the enclosed cross-reference, and have determined that they do not decrease the effectiveness of the Emergency Plan, since the changes are administrative and the Emergency Plan, as changed, continues to meet the standards of 10 CFR 50.47(b) and the requirements of 10 CFR 50, Appendix E.




