#### Gentlemen:

In accordance with 10 CFR 50.54(q), 10 CFR 50, Appendix E, and 10 CFR 50.4(b)(5), we are transmitting the enclosed revisions to the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2, Plant Emergency Plan and the Plant Emergency Procedures (PEPs). The effective date for the enclosed plan and procedure changes is May 31, 1996; therefore, this submittal is due by July 1, 1996.

We have reviewed the changes to our Plant Emergency Plan and determined that they do not decrease the effectiveness of the plan, and the plan, as changed, continues to meet the standards of 10 CFR 50.47(b) and the requirements of 10 CFR 50, Appendix E.

The procedure changes are the result of a revision to the entire body of PEPs and a redesignation as Emergency Procedures (EPs). A discussion of the changes is included as Enclosure 1. A cross-reference of the Plant Emergency Plan revisions with the affected section identified and a discussion of the reason for each of the changes is included as Enclosure 2.

### H. B. Robinson Steam Electric Plant, Unit No. 2 Revisions to Plant Emergency Procedures

The Emergency Preparedness (EP) procedure upgrade is an initiative to provide restructured and more user friendly emergency procedures. The change is largely administrative, and designed to enhance the overall structure of the procedures. A facility-based and, where appropriate, function-based approach is used to make locations of various procedures more intuitive to the user. Procedure efficiency is improved through reduction in the total number of procedures, consolidation of common sections into one generic section, improved format, and a "quick start guide" to aid personnel in start up duties.

In general, the information previously in the superseded Plant Emergency Procedures (PEPs) was incorporated directly into the new Emergency Procedures (EPs). A matrix which relates procedure locations to the procedures consolidated is attached for reference. Procedures are structured with a "parent" level document (e.g., Technical Support Center (TSC) Procedure -00) and position-specific or function-specific sections (e.g., TSC-01, TSC-02, etc.) within the parent procedure. Each section is controlled as an individual document with its own cover sheet, list of effective pages, and approvals to make procedure maintenance less difficult. Common references, responsibilities, and precautions are included at the parent level where these items are consistent with guidance in the plant procedure writer's guide.

Procedure comments previously collected, changes to the plant, and to the Emergency Preparedness program were incorporated. These changes include:

- 1. Deletion of the Logistics Support Director position and the resultant transfer of responsibilities and staff to the Administrative and Logistics Manager,
- 2. Consolidation of the Support Services functions, Craft/Equipment and Financial/Vendor, to one position,
- 3. Relocation of the Joint Information Center (JIC) media briefing area from the JIC trailer to the second floor of the Southern Region Office at the same location, and
- 4. Minor changes, such as room numbers, required by the renovation of the classrooms in the Technical Support Center/Emergency Operations Facility.
