SUMMARY OF CHANGE TO TECHNICAL REQUIREMENTS MANUAL

Purpose, Description, and Justification for the Change

The purpose of this change is to revise the Technical Requirements Manual (TRM) procedure references which have been replaced by other procedures. Procedure PLP-032, "10 CFR 50.59 Reviews of Changes, Tests, or Experiments," was replaced by Corporate procedure REG-NGGC-0002, "10 CFR 50.59 and Other Regulatory Evaluations." Procedure PLP-026, "Corrective Action Management," has been replaced by Corporate procedure CAP-NGGC-0001, "Corrective Action Management." Administrative Procedure (AP)-022, "Document Change Procedure," has been replaced by AP-021, "Development, Review and Approval of Changes to the Updated Final Safety Analysis Report and the Independent Spent Fuel Storage Installation Safety Analysis Report," as the administrative control procedure for control of changes to the TRM. The scope of procedure controls contained in the previously referenced procedures is contained in the new procedures referenced in Revision 3 to the TRM.

This change was approved in accordance with 10 CFR 50.59, which determined that the change did not result in a change to the operating license. Technical Specifications, or an unreviewed safety question, and the change was reviewed and accepted by the Plant Nuclear Safety Committee.
