Gentlemen:

Carolina Power and Light Company (CP&L) has received and reviewed the Systematic Assessment of Licensee Performance (SALP) transmitted by letter dated September 8, 1992. This report provided results from the evaluation period of March 31 through June 27, 1992. Also, CP&L had the benefit of comment and discussion during the NRC presentation of the SALP Report at our facility on September 24, 1992.

CP&L is pleased with the quantitative ratings of the SALP Board which reflect that the overall performance of H. B. Robinson was good and is improving. It is encouraging that acknowledgment was made of significant improvement in the area of plant operations and sustained superior performance in radiological controls and plant security.

The staff at H. B. Robinson Unit 2 is aware of the functional areas where performance was characterized as "mixed", and acknowledge that further management focus and attention is necessary to obtain superior performance in these areas. We recognize that the SALP ratings received depend to a certain degree on effective and timely implementation of future corrective actions, and we are committed to meeting these obligations. For areas where corrective actions are being developed or issues are being addressed, we are dedicated to completing these activities and providing auditable results.


