Gentlemen:

This will acknowledge receipt of your response of May 7, 1995, to our Notice of Violation issued on April 7, 1995, concerning activities conducted at your Robinson facility. We have evaluated your response and found that it meets the requirements of 10 CFR 2.201. We will examine the implementation of your corrective actions during our Emergency Operating Procedure and Abnormal Operating Procedure Inspection scheduled for June 12-16, 1995.

Our April 7, 1995 letter also requested that you address how implementation of corporate procurement engineering procedures ensure site specific commitments are met. Your response of May 7, 1995, indicated that your self-assessment of this area determined that no commitments were found to have been inadvertently negated. Inspection Report 50-261/95-08 detailed our concern regarding the possible negation of the commitment made in Licensee Event Report 93-17 to require system engineering review of procurement downgrades. Based on a telephone conversation on May 18, 1995, between Mr. Shymlock of Region II, and Mr. Garrou of your staff, it was agreed that a revised response to this issue would be provided.

The response requested by this letter is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, Pub. L. No. 96.511. Your cooperation in this matter is appreciated.
